1 On October 15, 2018, the Court issued an Order granting defendant Donald J.
2 Trump’s Motion to Strike/Dismiss (“Motion to Strike”) the Complaint of plaintiff
3 Stephanie Clifford (“Plaintiff”). [ECF No. 36.] In the Order, the Court held that Mr.
4 Trump “is entitled to attorney’s fees” under the Texas Citizens Participation Act (the
5 “TCPA”). [*Id.*, p. 14.]

6 On October 29, 2018, Mr. Trump filed a Motion for Attorneys’ Fees and
7 Monetary Sanctions (the “Motion”) under the TCPA. [ECF No. 39.] On November
8 5, 2018, Plaintiff filed an Opposition to the Motion. [ECF No. 40.] On November
9 12, 2018, Mr. Trump filed a Reply in support of the Motion. [ECF No. 41.] On
10 December 3, 2018, the Motion came on regularly for hearing in Courtroom 10C of
11 the above-entitled Court.

12 This Court, having read and considered the supporting and opposing points and
13 authorities and evidence, having heard the argument of counsel, and good cause
14 appearing therefor, hereby orders as follows:

15 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Judgment is
16 entered in favor of Donald J. Trump and against Plaintiff Stephanie Clifford in the
17 amount of \$ _____, including the amount of \$ _____ in attorneys’ fees
18 incurred to defend this lawsuit pursuant to Texas Civil Practice & Remedies Code §
19 27.009(a)(1), and the amount of \$ _____ in monetary sanctions pursuant to
20 Texas Civil Practice & Remedies Code § 27.009(a)(2).
