AMENDED PETITION FOR GAG ORDER

(as to change of parties only)

COMES NOW the Defendant, by and through undersigned counsel, and respectfully requests this Honorable Court to issue a gag order in this case directing all parties and their counsel, and those that are working in concert with their respective agents and employees either directly or indirectly with the parties and/or their counsel, consistent with 4.3-6 of the Rules Regulating the Florida Bar, not to participate, encourage, assist, or abet in the dissemination of any out-of-court publicity in this matter and as grounds therefore would state as follows:

1. That "In Florida, the limitations imposed by the court on communications between the media and lawyers and/or litigants must be for good cause to assure fair trials." *Rodriguez ex rel. Posso-Rodriguez v. Feinstein*, 734 So.2d 1162, 1164 (Fla. 3d DCA 1999) as cited in *E.I. Du Pont de Nemours and Co. v. Aquamar, S.A.* 33 So.3d 839, 840 - 841 (Fla.App. 4 Dist., 2010). Thus, a gag order should be supported by evidence and findings that any extrajudicial statements made by counsel or the parties pose a substantial or imminent threat to a fair trial. *E.I. Du Pont* at *id.*
2. That on multiple dates, multiple social media posts and statement have been made regarding this case. See attached Exhibit A.
3. That social media posts of this nature and of this magnitude pose a substantial and imminent threat to a fair trial.

WHEREFORE the Defendant respectfully requests this Honorable Court to enter a Gag Order in this case directing all parties and their counsel, and those that are working in concert with their respective agents and employees either directly or indirectly with the parties and/or their counsel, consistent with 4.3-6 of the Rules Regulating the Florida Bar, not to participate, encourage, assist or abet in the dissemination of any out-of-court publicity in this matter.

Attorney John Phillips to Hold Press Conference Wednesday December 11, 2018 to Announce Updates in the DUI Fatality Cases Involving Suspect Tanner Dashner

Fort Pierce, Florida – On November 23, 2018, the Treasure Coast had its worst motor vehicular collision in decades. Five people were killed and multiple were injured. 21-year-old Anthony Victor, 16-year-old Anthony M. Martin, 21-year-old Darien L. Douglas, 17-year-old Alexis Chaney and the driver of the Dakota, 27-year-old Kedan D. Tillett, all died as a result of some combination of extreme trauma, explosion, fire and/or smoke inhalation, caused by the high speed crash. Additionally, passenger Ari'yonnia Stanberry, a 14-year-old, was injured. It is believed others were injured as well.

Tanner Ray Dashner, a 21-year-old Fort Pierce native caused the crash. Initial reports on scene reflected that he was believed to be intoxicated. Evidence collected since the wreck substantiates that he was. Florida Highway Patrol and the State Attorney of the 19th Judicial Circuit claim they are still investigating. It is time to make an arrest. The Florida Highway Patrol wasted no time making an arrest of Kim Johnson when she rear-ended and killed a Jacksonville Sheriff's Officer over the weekend.

Attorney John Phillips was hired by the family of Alexis Chaney. He has investigated the crash

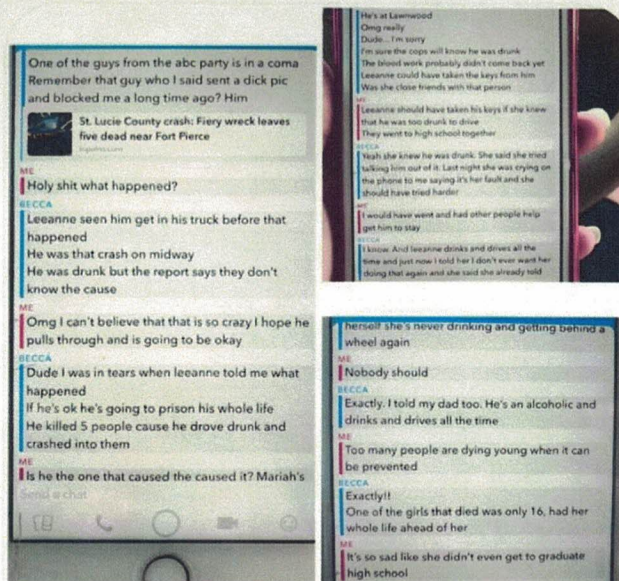
