

4. On July 12, 2016 I searched the online New York State Department of State Business Entity Database located at http://www.dos.ny.gov/corps/bus_entity_search.html for entities containing the term “Trump” and Trump 2012 PCA was not among the 150 foreign and domestic entities listed as the results of the search.

5. On July 12, 2016 I spoke with a clerk in the Division of Corporations of the New York State Department of State who at my request conducted a search of the department’s official records and advised me that there was no filing of the certificate for doing business under an assumed name required under NYGBL, § 130 for a corporation, limited liability company or limited partnership doing business under the assumed name “Trump 2012 PCA.”

6. On July 12, 2016 I spoke with a clerk in the office of the New York County Clerk who at my request conducted a search of the office’s official records and advised me that there was no filing of the certificate for doing business under an assumed name required under NYGBL, § 130 for a sole proprietorship, general partnership, limited liability partnership or any other entity (other than a corporation, limited liability company or limited partnership) under the assumed name “Trump 2012 PCA.”

7. NYGBL, § 130 (9) provides:

“Any person or persons carrying on, conducting or transacting business as aforesaid, who knowingly fails to comply with the provisions of this section or who knowingly makes a false statement in a certificate filed thereunder shall be guilty of a misdemeanor. Any person or persons carrying on, conducting or transacting business as aforesaid shall be guilty of a misdemeanor. Any person or persons carrying on, conducting or transacting business as aforesaid who fails to comply with the provisions of this section shall be prohibited from maintaining any action or proceeding in any court in this state on any contract, account or transaction made in a name other than its real name until the certificate required by this section has been executed and filed in accordance with the provisions set forth herein.”

8. On information and belief “Trump 2012 PCA” is not the name of a legal entity that is qualified to be filed with and authorized to do business in the State of New York.

9. New York Business Corporation Law (“NYBCL”), § 301(a)(1) provides:

(a) Except as otherwise provided in this chapter, the name of a domestic or foreign corporation:

(1) Shall contain the word "corporation", "incorporated" or "limited", or an abbreviation of one of such words; or, in the case of a foreign corporation, it shall, for use in this state, add at the end of its name one of such words or an abbreviation thereof.

10. New York Limited Liability Company Law § 208(a) provides:

Limited liability company name. The name of each limited liability company as set forth in its articles of organization: (a) shall contain without abbreviation the words "Limited Liability Company" or the abbreviation "L.L.C." or "LLC"

11. NYGBL, § 130 (9) provides:

“Any person or persons carrying on, conducting or transacting business as aforesaid, who knowingly fails to comply with the provisions of this section or who knowingly makes a false statement in a certificate filed thereunder shall be guilty of a misdemeanor. Any person or persons carrying on, conducting or transacting business as aforesaid shall be guilty of a misdemeanor. Any person or persons carrying on, conducting or transacting business as aforesaid who fails to comply with the provisions of this section shall be prohibited from maintaining any action or proceeding in any court in this state on any contract, account or transaction made in a name other than its real name until the certificate required by this section has been executed and filed in accordance with the provisions set forth herein.”

12. New York Partnership Law § 121-1501 provides:


“Name of registered limited liability partnership. The name of each registered limited liability partnership shall contain without abbreviation the words "Registered Limited Liability Partnership" or "Limited Liability Partnership" or the abbreviations "R.L.L.P.",

"RLLP", "L.L.P." or "LLP"; provided, however, the partnership may use any such words or abbreviation, without limitation, in addition to its registered name."

13. Pursuant to these cited statutes "PCA" is not a recognized name of a business entity in New York State.
