MOTION TO DETERMINE PARTIAL INDIGENCY
FOR COSTS OF DISCOVERY

COMES NOW, the Defendant, Tanner Ray Dashner, by and through undersigned counsel and moves this Court to enter an Order finding that the Defendant meets the indigency requirements for costs of discovery in the above-styled matter. In support thereof, the Defendant would state as follows:

1. That the Defendant has been charged with five counts of Vehicular Homicide, (F2), five counts of DUI-Manslaughter – Impairment and/or (.08), (F2), one count of Driving Under the Influence – Impairment and/or (.08)/Damage Person, (M1) and one count of Driving Under the Influence – Impairment and/or (.08)/Damage Property, (M1).
2. That the Defendant's Application for Indigency with the Clerk of Court is attached.
3. That undersigned counsel's law firm filed a Notice of Appearance on January 4th, 2019.
4. That the Affidavit attesting to the amount of attorney's fees of \$100,000.00 and the source of payment for those fees, as required by Florida Statute §27.52(5)(a)2, is attached to this motion.
5. That \$100,000.00 is a reasonable fee for this defendant, as it involves ten (10) second degree felonies and two first degree misdemeanors.
6. That the undersigned counsel has been retained by the Defendant's family; however, no monies are available for discovery costs such as; investigative services, the use of process servers, or the preparation of transcripts.

WHEREFORE, the Defendant prays this Honorable Court will grant the relief requested by this motion.



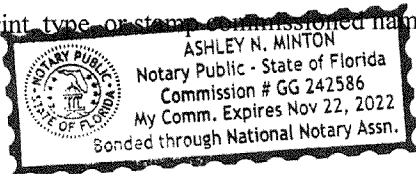
