PAUPERIS**


I, Larry Klayman, being over eighteen years of age, hereby swear and  
declare as follows:

1. On April 9, 2013 I visited the CA Secretary of State's Business Search  
website wherein I searched for Plaintiff's corporation, Rodeo Fine Jewelry,  
Inc. A true and correct copy of the search results are attached as Exhibit A.

- 1       2. On the Secretary of State's website it indicated that Plaintiff Martin Kempe  
2           is the agent for service of process for Rodeo Fine Jewelry, Inc. which is still  
3           located and in operation at 9608 Brighton Way, Beverly Hills, CA 90210.
- 4       3. The Secretary of State's website indicated that the corporation has been  
5           suspended.
- 6       4. On April 9, 2013, I walked to Plaintiff's jewelry store where I took a picture  
7           of the outside of the store, which was still open for business. A true and  
8           correct copy of the picture is attached as Exhibit B.
- 9       5. On display in the window at the store were still thousands of dollars worth  
10           of jewelry. I am aware that Plaintiff has kept hundreds of thousands, and  
11           perhaps millions of dollars worth of jewelry in his inventory and on  
12           information and belief continues to do so.
- 13       6. Inside the store I could see Plaintiff Martin Kempe working behind the  
14           counter just as he had when I first met him at the jewelry store back in 2008.  
15           He is thus not unemployed as he has falsely represented in his Motion For  
16           Leave to Appeal in Forma Pauperis. In fact, he has admitted to being the  
17           owner of Rodeo Fine Jewelry.
