### **DETAILS OF INVESTIGATION**

#### **Inquiry by Indiana Department of Natural Resources (INDNR) Regarding Robert ENGESSER Activity in Kokomo, Indiana**

On September 13, 2018, INDNR Detective Sergeant Brian Kaser was requested by U.S. Fish and Wildlife Service/Office of Law Enforcement (USFWS/OLE) Special Agent (SA) Matthew Bryant to determine if Robert ENGESSER was in Kokomo, Indiana at Button Dodge dealership during November 2018 (See Report 040). Detective Kaser determined ENGESSER was at the dodge dealership on November 21, 2017, but no other information was discovered indicating he was there before or after that date in November 2017. (See attachment #1, INDNR Incident Report).

#### **Follow-Up Interview of ENGESSER**

On October 24, 2018, SA Bryant and Federal Bureau of Investigation (FBI) SA Andy Farabow conducted a telephone interview with ENGESSER at the FBI Office in Norman, Oklahoma (See attachment #2, ENGESSER Re-Interview).

On this same date, but after the interview was concluded, ENGESSER text SA Bryant an image of two (2) forms documenting the movement of a lion cub from Florida to Texas in November 2017 (See attachment #3, Transfer Forms).

I, Det. / Sgt. Brian Kaser, was asked to provide assistance to the USFWS in regards to a suspect and his associated vehicle. I was provided information that a suspect in an ongoing USFWS investigation may have had his vehicle in Kokomo Indiana for repair during the time of a suspected illegal wildlife transaction. Information provided was that at some point during November 2017 Robert ENGESSER had a 2008 white Dodge dually truck at Button Dodge for some type of service and or repair. I was asked to verify if ENGESSER or his associated truck had been at the place of business and what dates he or the truck had been there.

**09-14-2018**

I made contact at Button Dodge located at 1220 E Blvd Kokomo IN 46902. I spoke with Service advisor Garrit Stryker and asked if he could locate a possible vehicle service at the dealership with the owner name. STRYKER was able to locate the vehicle using the VIN number of ENGESSER's dodge truck. STRYKER was able to see that the vehicle in question had actually been at the dealership's associated body shop, Abra. STRYKER told me that the body shop would have better records.

I made contact at Abra and was told I should talk Brandon RENBARGER, who was the production manager. I was told RENBARGER was not in the office and that I could leave a written request if I wanted. I told them I would rather return to discuss the matter in person.

**09-20-2018**

I made contact with RENBARGER at Abra auto body and repair. I explained that I was looking to verify that a particular owner and or truck had been at his business in November of 2017. I provided the last 6 numbers of the VIN of the truck in question and the owner name. As soon as RENBARGER located the truck in his record system he told me he remembered this guy. I was told that the truck had been involved in a collision and had arrived at the body shop on 09-22-2017 and repair was finished and the vehicle left on 12-22-17. I asked if the truck ever left the body shop during that time period.

Upon looking at notes in the file RENBARGER told me that ENGESSER had called on 11-8-17 and wanted to pick up the truck on 11-17-17. He told me he remembered getting the truck ready and no one showed up on the 17<sup>th</sup>. RENBARGER said he remembered something about early the next week ENGESSER showed up and refused to take it due to body lines being wrong and tire/wheel issue. RENBARGER said he remembered the guy with ENGESSER saying how tired he was because they drove all night to get up here. A report in the file showed the truck was taken to get a tire/wheel repair on 11-21-17 and was gone for about 1 hour at approximately 1530 hours. In the file there was a copy of a report that ENGESSER signed on 11-21-17. RENBARGER said ENGESSER had to be in the shop on that date to sign the report.

On 11-22-17 the truck was towed to Indianapolis to Palmers Frame shop to have the frame pulled. Reports

showed there were two more telephone calls from ENGESSER to Abra to discuss the frame and repair, one on 11-24-17 and the other on 11-28-17. The truck was towed back to Abra from Palmers on 12-13-17. The report showed that the truck was released to ENGESSER on 12-22-17.





## FEDERAL BUREAU OF INVESTIGATION

Robert L. Engesser, white male, date of birth [REDACTED] 1965, social security number [REDACTED]-2555, was contacted at telephone number (352)246-6942. Special Agent (SA) Matt Bryant, United States Fish & Wildlife Service, participated in the interview. Engesser's wife, Pat Engesser, was present with Engesser during the interview. The information set forth below is an interview summary. It is not intended to be a verbatim account and does not memorialize all statements made during the interview. Communications by the parties during the interview were recorded on audio and video equipment used by SA Bryant. The recording captures the actual words spoken. Engesser was advised of the identities of the interviewing Agents and the nature of the interview. Engesser then provided the following information:

Engesser has known Joe Maldonado for several years. Engesser purchased tiger cubs and lion cubs from Maldonado on numerous occasions.

In late 2017, Maldonado asked Engesser to "advance" him money for a cub. Engesser sent a wire transfer to Maldonado sometime in late 2017 but he did not actually receive the cub from Maldonado until early 2018. Engesser did not recall the amount of this wire transfer.

Engesser was asked specifically about a MoneyGram in the amount of \$1,000.00 that he sent from a Wal-Mart in Big Spring, Texas, to Maldonado on November 18, 2017. Engesser acknowledged that he was in Big Spring, Texas, during November 2017, but advised that he did not recall this particular wire transfer. Engesser advised that any money he sent to Maldonado would have been for the purchase of a cub and that he would not have sent money to Maldonado for any other reason. (During the interview, Pat Engesser attempted to locate records pertaining to this wire transfer, but was unable to locate any).

Engesser did not recall obtaining a tiger cub or lion cub from Maldonado during November 2017.

Cody Bridgmon rode with Engesser from Big Spring, Texas, to Palestine, Indiana, in November 2017. They arrived in Indiana on Tuesday, November 21, and left the following day. The purpose of the trip was to pick up Engesser's truck but it was not in good condition. Engesser and Bridgmon traveled to and from Indiana in Engesser's cousin's Dodge 3500 pick-up truck. Engesser did not recall stopping at GW Exotic Animal Park in Wynnewood, Oklahoma, during this trip. Neither Engesser nor any of his employees drove a red sedan.

Tony Crawford and Anthony Farmer worked for Engesser on the traveling shows. Engesser also hired local help during the shows.

Engesser learned of Maldonado's alleged involvement in a plot to murder Carole Baskin through news reports.

Engesser no longer owns any tiger cubs or lion cubs. Engesser plans to begin working as a truck driver in the near future.
